David Gentry, Virginia, A044122

- Patriotic Service
- Born: circa 1724, Hanover Co VA
- Died: 1812, Madison Co KY

David is believed to be the son of Nicholas Gentry (b 1697 d 1779) and Mary Brooks from New Kent Co, VA which became Hanover Co in 1720. David married twice.

His first wife, Jane Kendrick, died by 1747-48 leaving one son, William. Mary Estes, b. 6 Apr 1731, Pamonkey River, King & Queen Co, VA, married David 16 Jul 1758, Louisa Co, VA. She died about 1812, Albemarle Co, VA. Four known children were born to David and Mary. NSDAR recognizes daughters from all four children.

- O David b 11 Nov 1761, Louisa Co, VA and d 1813, Madison Co, KY married his second wife Jane Haggard about 1784. Jane born 1761, Louisa Co, VA and died in KY after 11 Mar 1807. David had five children from his first wife, Jane Kendrick. He had seven children by his second wife also Jane.
- o Richard William b 26 Sep 1763, Louisa Co, VA and d 12 Feb 1843, Madison Co, KY. He married Jane Harris b 18 Sep 1763, Albemarle Co, VA and d 17 Sep 1821, Madison Co, KY. There were married on 5 Apr 1784, Albemarle Co, VA. He had twelve children by Jane and seven children by his second wife Nancy Guthrie.
- Winifred A. (b 15 Sep 1765 d 29 Aug 1852/3) married William Martin (b 1765 d 1841) in 1789 in KY.
- Onie/Oney (b 1 Dec 1767, Albemarle Co, VA, d 2 Jan 1823, Howard Co, MO) married David Martin, then William Blythe and then John Cain. She married Cain (b 1770 NC d 1853, Adair Co, MO) on 18 Jul 1803, Madison Co, KY.

David is attributed with Patriotic Service in Hanover Co, VA for furnishing one beef in Nov 1781 and for 247 pounds of beef on 5 Apr 1782 (paid L2-9-4.75). He is also credited with a gun impressed for militia use on 11 May 1782 (paid L1-10S).
