John Wagle, North Carolina, A209968

• Patriotic Service

• Born: 9 Oct 1751 PA

• Died: 28 Jul 1818, Madison Co KY

There are multiple spellings of the Wagle name including Wegel, Wegle, Wagel, Weaugh, Weagle, Weighey and Weighley.

John Wagle was the son of John Adam Wagle (A119977) (1718-1802) and Mary Briney/Brinich (1739 PA- 1783 PA). John Adam Wagle was a weaver by trade.

John had several siblings: Elizabeth, Sarah, Abraham (A119971), Isaac (A119972) Joseph and Jacob.

On 26 Mar 1778, John married Jemima Todd (b 19 Jan 1759 PA d 30 Apr 1850 Madison Co KY). As of Summer 2021, NSDAR recognizes daughters from Mary. The children of John and Jemima Todd were:

- o John (b 23 Dec 1778 ND d Dec 1780 NC).
- Mary Polly (b 3 Jul 1781 NC d a 5 Jul 1852 Madison Co KY) married Jesse Cox (c 1780 SC d 22 May 1861 Estill Co KY) on 16 Dec 1803 in Madison Co KY.
- o Isaac (b 22 Aug 1783 NC d 3 Apr 1841 KY) married Phoebe Todd.
- o John Jr. (b 17 Oct 1785 d 4 Nov 1806 KY) married Mary Owen.
- o Ezekiel (b Dec 1787 b Apr 1788).
- o Thomas (b 25 Jun 1791 d 25 Mar 1864) married Mary Cox.
- Elizabeth (b 9 Dec 1795 d 30 Jul 1799).
- o Lewis (b 10 Jul 1800 d 2 Nov 1826) married Charlotte Kelly.

John is credited with suppling a gun for the war.

There are other war records citing military service for a John Wagle, yet it could not be proven it was this John Wagle, son of John Adam Wagle.
