## Shubael Dearborn Jr, New Hampshire, A031161

- Patriotic Service, Militia
- Residence: Northfield Rockingham Co, NH
- Born: 12 July 1753, Hampton Rockingham NH
- Died: 19 Feb 1802, Northfield Rockingham Co NH

Shubael lived in Rockingham County all his life. He married Ruth Leavitt in 1779 at Northfield Rockingham Co NH. Ruth was born 1 Aug 1761 at Hampton NH and died at Northfield Merrimack Co NH on 19 Apr 1854. Find a Grave indicates that they are buried at Hodgon Cemetery, Northfield NH.

As of summer, 2021 two of Shubael and Ruth's children have proven DAR daughters. They are:

- Jonathan born 15 Jun 1781 at Northfield Rockingham Co NH and died at Northfield Merrimack Co NH on 16 Jul 1852. Jonathan married Elizabeth Kenniston in 1803 and had 7 children including a daughter Eliza who was born in 1811 and died in 1910 five months short of her 100<sup>th</sup> birthday. Elizabeth was born 23 Dec 1782 at Northfield Rockingham Co NH and died at Northfield Merrimack Co NH on 30 Oct 1866.
- Shubael 3<sup>rd</sup> born in 1783 and died at Northfield. His second wife was Sally Glines who was born in 1783. They were married in 1869.

Shubael enlisted as a private at Canterbury NH on 27 May 1775. He served in Captain Jerimiah Clough's company in Col. Enoch Poor's regiment until 1 August 1775. This was the 2<sup>nd</sup> NH Regiment. He remained a member of the same company at least until 4 Oct 1775. He was also on a bounty roll of Capt. James Shepard's company, Col Isaac Wyman's regiment, dated Boscawen 2 July 1776. Boscawen, NH is now in Merrimack County, NH.

The DAR application also said that he also served under 2<sup>nd</sup> Lieutenant Thomas Lyford in a NH Regiment on the Continental line.
