PROTOCOL POINT

Parliamentary Procedure - Parliamentarian

The National Parliamentarian is appointed by the President General, with the approval of the Executive Committee; the State Parliamentarian by the State Regent, with the approval of the State Executive Committee and the Chapter Parliamentarian by the Chapter Regent, with the approval of the Chapter or the Chapter Executive Board.

The Parliamentarian is a consultant on parliamentary procedure, helping to expedite meetings in accordance with the Articles of Incorporation, Bylaws, Special Rules of Order, and the adopted parliamentary authority (*Robert's Rules of Order Newly Revised*).

The Parliamentarian is an important person to the Regent to guide her with the order of business in the Regent's agenda. For DAR meetings the Parliamentarian will sit near the presiding officer so that advice may be given quickly and quietly.

The Parliamentarian cannot be an officer as she should remain neutral and therefore does not vote except on a ballot vote.

IMPORTANT NOTE: REGENTS, be sure your Parliamentarian has a copy of your agenda for the meeting so she can follow along and respond quickly if you forget an item in your agenda or need a question answered.

ALSO NOTE that your Recording Secretary should have a copy of your agenda so that she can insert notes at each item of business to be able to write complete and accurate minutes. This is part of the fundamental principles of protocol that are dictated by ethics, courtesy, good manners and common sense for recognizing those who are also in positions of leadership and are helping you.

THE IOWA ROOM: OUR CORNER IN WASHINGTON, D.C.

Featured in this issue is the Eli Terry scroll and pediment shelf clock adorning the wall of the Iowa Room. Although sans weights and right pulley cord and no longer in working order, it is a prime example of the artistry of such timekeeping pieces. Eli Terry (1772-1852), a Plymouth, Connecticut clockmaker, patented his shelf clock mechanism and is known for introducing mass production to clock making. His innovations made clocks affordable to the average American citizen. Our clock, sometimes referred to as a bracket clock, was produced circa 1820, and is of pillar and scroll design with brass escapements. The glass panel in the bottom is painted on the reverse side, illustrating a homestead scene reminiscent of Mount Vernon. The height is 31-1/2 inches and the width 15-1/2 inches.

When the clock appeared on the DAR Museum's "Adopt-an-Object" list, lowa Daughters declared it was NOT an orphan! In 1995, funds remaining from the State Regent Project 1992-1994 (Iowa Room Renovation) allowed for necessary conservation. In 2001, a period-appropriate shelf for the clock was handcrafted in a mahogany vertical grained veneer by Period Designs of Yorktown, Virginia. This project was funded from the 1992-1994 project and the Iowa Society DAR.



Florence Clapp Cunningham, member of Mayflower Chapter, Cedar Rapids, generously donated the clock to the museum. The clock belonged originally to Isaac Beals of Avon, Massachusetts, her grandfather. Iowa Room records do not reflect the date of donation.

Please note: Hope you did not miss this! In the July/August issue of our national newsletter (p. 272), the DAR Museum Featured Object subject was none other than the Iowa Room's own portrait of Captain Oliver Blanchard. The story is fascinating, and more research is being done. Please watch this series for more on the dashing Captain Blanchard.

Historical markers are refreshed by Abigail Adams Chapter

A "baker's dozen" from the Abigail Adams Chapter participated June 22 in rededication ceremonies for DAR's five historical markers in downtown Des Moines. The project began two years ago, when Bill Sherman, a long-time Polk County preservationist, contacted member Sara Jane Harwood. He proposed that we clean up our historic monument near the I-Cubs ballpark. Construction of the Principal Riverwalk, a weekly Farmers Market on Court Avenue, and the extension of M. L. King Parkway, all contribute much higher visibility of the monument. We agreed it was high time it be restored to an honorable visage! Over the ensuing months, Mrs. Harwood worked with Mr. Sherman and Pete Sixbey, a conservationist at the Iowa State Historical Society. Now, it was time to tour the sites, inspect the work, and rededicate markers placed by our predecessors!

The first two markers flank a monument beside the river on South Water Street. These mark the original Fort Des Moines and the Dragoon Trail.

Sara Jane Harwood gave us some background about the historical marker and the reason it was placed.

Regent Nedra Markham and Chaplain Sandra Durby performed the NSDAR ritual. This was done at each site.

Then, members enjoyed a talk by Mr. Sherman about "The Birthplace of Des Moines". He included information about the colorful tile mural along the I-Cubs parking lot. After his formal talk, Mr. Sherman opened the historical cabin, between the mural and our monument, for members to view.


Next, the Chapter caravan crossed the river







and proceeded to the Grand Avenue bridge by City Hall. Here, in 1933, Abigail Adams marked the city's first ferry, first pontoon bridge, and first toll bridge. This monument is a 3-ton pink granite boulder, engraved, and embellished with a bronze NSDAR insignia.



Last marker on the road trip is at 9th and Locust St. This bronze tablet commemorates Des Moines' first public school.

Jolene's grandmother was a professional seamstress, and her mother, (Jessie Thompson, chapter DAR member) did the sewing for her family of nine children. They passed the love of sewing on to Jolene. In the picture at right, Jolene is wearing the dress her mother Jessie had made for



herself for her 25th wedding anniversary in 1969. The picture in front of Jolene is of the Thompson family taken for the occasion, and Jessie is wearing the dress. The picture was hand tinted and did not show the correct colors. it was a Vogue pattern and is very much in style today. It fit Jolene perfectly. The white dress on the form was made and worn by Jolene's grandmother of which Jolene had a picture of her grandma wearing the dress. Jolene has two daughters, both members of Nancy McKay Harsh Chapter, and these are their dolls. Jolene made dresses for the girls and look a likes for their dolls. The girls dresses were also shown. The picture in front of the dolls are the girls holding their dolls. Jolene had many dresses made by her grandmother, mother Jessie and by Jolene herself. Her grandmother was a professional seamstress and had taught Jolene how to sew. One especially interesting one (you can see the green article behind the dolls) is a fancy little dress made of green crepe paper with a feed sack backing, made by Jessie's mother for her when she was about in 3rd grade. The school had a May Day festival and Jessie wore this dress as she danced around the May pole. Of course there was a picture of her taken at the time. Nickie, Jolene's daughter was with her and she carried the dresses and pictures around to show the members as Jolene talked about each article. Jolene's mother Jessie had entered lots of the dresses and pictures in the county fair and with each entry had written a little story about the article and the person that made it. She normally got a blue ribbon. She had saved the articles, pictures and stories all together and Jolene had them all. She lives in Tennessee and could not bring everything, but she had a wonderful collection with her. She told many interesting stories about her family of seamstresses. It was a wonderful program!

Abigail Adams Chapter nominee awarded NSDAR Historic Preservation Medal

Gerald A. LaBlanc, a 20+ year volunteer at Des Moines' Woodland Cemetery, has received the National Society's Historic Preservation Medal. Preservation, education and restoration has been Mr. LaBlanc's mission. This retired teacher has given hundreds of tours to students and civic groups; he has organized restoration of grave stones of Civil War and World War I servicemen; and has been a vigorous fundraiser for this historic treasure. Established in1848, the 47-acre Woodland Cemetery comprises 27,000 graves, including those of three Real Daughters, whose monuments display the NSDAR insignia and designation. The City of Des Moines honored Mr. LaBlanc in a ceremony June 8th to dedicate a new "antique" archway at the entrance, and unveil a plaque recognizing his service. Abigail Adams Vice Regent Laura Kozin spoke on behalf of the chapter, announcing the NSDAR award. Also participating were past president Iowa SAR Mike Rowley, color guard from Co. A 49th IA Veteran Volunteer Infantry Regiment, and the City Brass Quintet.

decorated two windows of the Winfield Museum. The display commemorated Flag Day and the 4th of July. Also displayed were items recognizing NSDAR, the James Harlan chapter members and members of the former Winfield chapter. Judy Rawson prepared the display.

Hannah Lee Chapter Tour...

Members of Hannah Lee Chapter of Daughters of the American Revolution toured three northeast Iowa locations on August 3rd. These areas had been marked as significant historic sites by the organization. Each is commemorated with a bronze plaque. At each stop, Becky McCabe, Vice-Regent of the chapter gave a brief presentation about the site. St. Anthony of Padua Church near Festina was the first stop on the tour. The tiny chapel with seating for four is located in Winneshiek County is known as the "world's smallest church". The plaque there is located on a large boulder near the back of the cemetery. It was placed in 1925 by the Waucoma Chapter of DAR and bears the inscription, "Johann Gaertner fought with Napoleon Bonaparte at Moscow and Waterloo". Gaertner and his family built the chapel in 1885 to

fulfill a promise made by his mother in 1790 that if he

survived the Napoleonic War in Russia she would have a chapel erected in honor of the Blessed Virgin Mary in thanksgiving for his life.

The second spot visited by the group was at Dunham's Grove Cemetery southwest of West Union. Located in the older part of the cemetery is the burial place of Emily Carter. It is marked by a tall red granite memorial. The bronze plaque affixed to the memorial is inscribed "REAL DURGHTER" and bears the DAR symbol. Mrs. Carter who died in 1908 was the daughter of a revolutionary war patriot and as a DAR member is referred to as a "Real Daughter". She was a member of the Wenonah Chapter DAR and the plague was placed by Hannah Lee Chapter on the behalf of

the Wenonah Chapter.



The final stop on the tour was at the site of the first log cabin built by white settlers in Fayette County in 1840. Located north of Fayette, the bronze plaque is mounted on a boulder and surrounded by a semi-circular wall of large rocks build up to a height of three feet and by native vegetation. The inscription reads, "This marks the site of the first cabin in Fayette County. Here Franklin Wilcox built a home." The plaque at this historical site was put in place in 1940 by the DAR Chapters Waucoma, Hannah Lee and Wapsipinicon.



She shares this information with members of the Boone and Boone Area High Schools when they are planning class reunions.

Every chapter can give two C.S.A.s each year. NSDAR has made the process so much easier and less expensive by requiring only one copy of the documentation to be sent to the State Chairman who determines the completeness of the entry. Then the application form and a \$7.00 chapter check is sent on to order the certificate and pin from the NSDAR Store, requiring just one first class mail stamp. The process moves along quickly too, so you may receive the certificate and pin in a just a few days. There is no deadline for applying for the C.S.A. I am looking forward to having my mailbox full as EVERY CHAPTER participates in this opportunity to honor one or two of YOUR COMMUNITY LEADERS WHO MAKE A DIFFERENCE BY VOLUNTEERING!

AMERICA CELEBRATES U.S. CONSTITUTION DAR Promotes Constitution Week Awareness

WASHINGTON, DC – September 17, 2013, begins the national celebration of Constitution Week. The weeklong commemoration of America's most important document is one of our country's least known official observances. Our Constitution stands as a testament to the tenacity of Americans throughout history to maintain their liberties and freedom, and to ensure those inalienable rights to every American.

The tradition of celebrating the Constitution was started many years ago by the Daughters of the American Revolution (DAR). In 1955, the Daughters petitioned Congress to set aside September 17-23 annually to be dedicated for the observance of Constitution Week. The resolution was later adopted by the U.S. Congress and signed into Public Law #915 on August 2, 1956 by President Dwight D. Eisenhower. The aims of the celebration are to (1) emphasize citizens' responsibilities for protecting and defending the Constitution, preserving it for posterity; (2) inform the people that the Constitution is the basis for America's great heritage and the foundation for our way of life; and (3) encourage the study of the historical events which led to the framing of the Constitution in September 1787.

The United States of America functions as a Republic under the Constitution, which is the oldest document still in active use that outlines the self-government of a people. This landmark idea that men had the inalienable right as individuals to be free and live their lives under their own governance was the impetus of the American Revolution. Today, the Constitution stands as an icon of freedom for people around the world.

"Constitution Week is the perfect opportunity to read and study this great document which is the safeguard of our American liberties," states DAR President General, Lynn Forney Young. "We encourage all citizens across the country to take time this week to reflect on our heritage of freedom and come together to Celebrate America!" DAR has served America for 123 years as its foremost cheerleader. In 1928, the Daughters began work on a building as a memorial to the Constitution. John Russell Pope, architect of the Jefferson Memorial, was commissioned to design the performing arts center, known as DAR Constitution Hall. Today, DAR Constitution Hall is the only structure erected in tribute to the Constitution of the United States of America.
